### **END USER LICENSE AGREEMENT (EULA)**

**By downloading We Sound Effects Free Bundle, you agree to be legally bound by the terms of this Agreement. If you do not, or cannot, agree to the terms of this Agreement, do not attempt to download or use the We Sound Effects Free Bundle.**

This End-User License Agreement is a legal agreement between We Sound Effects (“Licensor”), and the individual or entity accepting this Agreement (“Licensee”).

#### **GRANT OF LICENSE**

On each sound libraries purchase the Licensor grants to the Licensee (you) a non-exclusive, worldwide, perpetual and royalty free license to use the sound libraries in accordance with the following terms and conditions.

#### **RIGHTS GRANTED TO YOU**

- To use the licensed sound effects for personal and commercial projects.
- To use the licensed sound effects on unlimited projects. Perpetual license.
- To synchronize the licensed sound effects with audio and/or visual productions and applications such as (not limited to): film & video productions, commercials, radio, theatre, live performances, musical production, computer/video games, multimedia projects, web pages and mobile apps.

#### **LIMITATIONS OF USE**

- You may not rent, lease, loan, sell, sublicense, or in any other way attempt to redeem economical profit through distribution of the sound libraries.
- You may not incorporate the licensed sound effects libraries into any software intended for development purposes or other end user products.
- You may not claim authorship of the sound effects; even if you manipulated and edited any sound effect, these new sound effects would not be your original compositions.
- In addition, the sound effects provided may not be repackaged in whole or part as new sample libraries. Re-using or adaptation of the sound effects as part of the creation of a new sample, stock library asset or virtual instrument is strictly prohibited.

#### **RESERVATION OF RIGHTS**

The Licensor only licenses the use of the sound effects to the Licensee; the sound effects providers will always retain full rights concerning all the content provided. The Licensor reserves all rights not expressly granted to you.

#### **LIMITATION OF LIABILITY**

In no event the Licensor be liable for any damages (including, without limitation, lost profits, business interruption, or lost information) rising out of ‘Authorized Users’ use of or inability to use the sound libraries.

#### **INDEMNITY**

Licensee must indemnify the Licensor from, and against any claims, demands, damages, suits, injuries, liabilities and all expenses, incurred by the Licensor with respect to any matter that arises as a result of a reported violation of this Agreement by the Licensee.

## **TERMINATION**

The Licensor will prosecute any violation of this agreement and will take any actions it deems appropriate depending each case, including terminating your license to use the sound effects without prior notice. In such case, all Licensee granted rights will cease immediately and Licensee must remove/delete all copies of the sound effects, as well as any related content.

## **APPLICABLE LAW**

This agreement is governed by the law of Spain, any dispute or claim will be under Spanish law.
